

PRICE LIST (RESIDENTIAL SWITCHING BY COMMUNICATIONS PROVIDERS) VERSION 1.1

Introduction

This **Price List** is a schedule to our agreement with you.

It sets out the **charges** for use of our **production hub** and **Services** for **residential switches** by **CPs**.

Charges for use of our **production hub** and **Services** for **business switches** will be set and published separately.

Our charges to intermediaries (also known as managed access providers or third-party integrators) will be set and published separately.

This **Price List** sets out:

- the **charges** to **CPs** for access to our **hub** and the **Services** for **residential switches**; and
- **our** terms of payment.

This schedule does not set out details of our invoicing or late payment collection processes. That information is set out in our **Billing and Payment Process**.

Your obligations

During onboarding you must tell us your **Residential Customer Number** as at 30 June 2023, rounded down to the nearest hundred.

From 2024 onwards, you must tell us your **Residential Customer Number** within three months of each annual **Reference Date**.

What do words mean in this schedule?

In this **Price List**, the following words have the following meanings:

charging period	each twelve-month period commencing on 1 January each year
Reference Date	In respect of each charging period , 30 June in the prior year
Residential Customer Number	for each RCPID , in respect of each charging period , the number of residential customers contracted for (i) fixed broadband, (ii) fixed voice; and (ii) fixed broadband/voice bundles with such RCPID at the applicable Reference Date
Subscription Price	£350 per RCPID per charging period
Unit Price	28 pence (£0.28) per residential customer per charging period

Exceptional charging and billing arrangements for January – June 2024

For the period 1 January 2024– 30 June 2024:

- there is no change to the charging or billing for the four largest **CPs** (i.e. they will be issued with quarterly invoices in advance for payment in accordance with terms); and
- other **CPs** will not be charged or invoiced by **us** (and **we** will issue credit notes for any invoices already issued).

For the avoidance of doubt, in the period 1 July 2024 – 31 December 2024:

- there is no change to the charging or billing for the four largest **CPs** (i.e. they will be issued with quarterly invoices in advance for payment in accordance with terms); and
- other **CPs** will be issued with quarterly invoices in advance for payment in accordance with terms. Each of these two quarterly invoices will be for one quarter of **your** annual **charge**.

These exceptional charging and billing arrangements are not linked to the **OTS go-live date**, and **you** should budget and plan accordingly.

Charging Structure and payment terms

Subject to the exceptional charging and billing arrangements for the January -June 2024 period set out above, **we** will invoice **charges** to each **RCPID** quarterly in advance.

Where a legal entity or group (an economic undertaking) owns or controls more than one **RCPID** **we** may aggregate **RCPIDs** (i.e. aggregate the number of residential customers across the undertaking) for the purposes of calculating **charges**.

Invoices are due and payable within 60 days of the invoice date.

Subject to the exceptional charging and billing arrangements for the January -June 2024 period set out above, our annual **charge** will be invoiced in four equal parts and each invoice will be sent in advance.

You may choose to receive instead a single annual invoice on the same payment terms. If **you** choose this option, **we** will reduce that single invoice by £50.

VAT at the prevailing rate will be added to each invoice.

Our charges

Subject to the exceptional charging and billing arrangements for the January -June 2024 period set out above, from 1 January 2024 the annual **charge** for each **RCPID** has two components:

- (i) a subscription **charge** for each **charging period** to cover the costs of maintaining and supporting an **RCPID**; and;
- (ii) a unit **charge** for each **charging period**, calculated from each **RCPID's Residential Customer Number** at the applicable **Reference Date** multiplied by the **Unit Price**.

For each **RCPID** with a **Residential Customer Number** more than 10,000 the annual **charge** will comprise a subscription **charge** set at the **Subscription Price** plus a unit **charge** calculated by multiplying the **Residential Customer Number** by the **Unit Price**.

RCPIDs with less than 10,000 residential customers are subject to a discount and tiering. For each RCPID with a **Residential Customer Number** less than 10,000 the annual **charges** are shown in the table below.
