

FULL MANAGEMENT MAP PRICE LIST (RESIDENTIAL SWITCHING) VERSION 1.1 – EFFECTIVE [.]

Introduction

This **Full Management MAP Price List** is a schedule to our agreement with you.

It sets out the **charges** for use of our **production hub** and **Services** for **residential switches** made via a **Full Management MAP**.

Charges for use of our **production hub** and **Services** for **business switches** will be set and published separately.

Our charges to **CPs** directly connected to our **production hub** are set out in our User Agreement, Schedule G Price List. These charges will also apply to **CPs** that use an **In-Sourced MAP** solution or a **Technical MAP** and maintain a direct commercial relationship with us.

This **Full Management MAP Price List** sets out:

- the **charges** to **Full Management MAPs** for access to our **hub** and the **Services** for **residential switches**; and
- our terms of payment.

Your obligations

You must:

- tell us the **Residential Customer number** of each of your **CP** customers when you onboard each **CP** customers and then on an ongoing basis within three months of each annual **Reference Date**; and
- if any of your CP customers acquires more than 100,000 new residential customers from another CP within any three month period (other than as a result of successfully completing residential switches in the ordinary course of business), you must tell us the date your CP customer acquired such additional residential customers and the number of additional residential customers your CP customer acquired.

What do words mean in this schedule?

In this **Full Management MAP Price List**, the following words have the following meanings:

charging period	each twelve-month period commencing on 1 January each year
Reference Date	In respect of each charging period , 30 June in the prior year
Residential Customer Number	for each RCPID , in respect of each charging period , the number of residential customers contracted for (i) fixed broadband, (ii) fixed voice; and (ii) fixed broadband/voice bundles with the RCPID at the applicable Reference Date

Subscription Price	£50 per RCPID per charging period
Unit Price	for each RCPID , 28 pence (£0.28) per residential customer per charging period , subject to a tapered reduction if the number of residential customers per RCPID is below 10,000.

Charging Structure and payment terms

Our charges start from 1 July 2024.

We will invoice **charges** in respect of each **RCPID** allocated to your **CP** clients.

Invoices are due and payable within 60 days of the invoice date.

VAT at the prevailing rate will be added to each invoice.

Our charges

The annual **charge** for each **RCPID** has two components:

(i) a subscription **charge** for each **charging period** to cover the costs of maintaining and supporting an **RCPID**; and;

(ii) a unit **charge** for each **charging period**, calculated from each **RCPID's Residential Customer Number** at the applicable **Reference Date** and **Unit Price**. In circumstances where any of your CP customers acquire more than 100,000 residential customers from another CP within any three month period (other than as a result of successfully completing residential switches in the ordinary course of business), we may increase your unit charge (and reinvoice you) to reflect your CP customer's increased number of residential customers from the date that your CP customer acquired such additional residential customers.

For each **RCPID** with a **Residential Customer Number** more than 10,000 the unit **charge** will be calculated by multiplying the **Residential Customer Number** by the **Unit Price** and then deducting £280.00.

For each **RCPIDs** with a **Residential Customer Number** less than 10,000 the unit **charge** will be subject to tiering and a tapered reduction as shown in the table below.
